2020 Nominating Committee Report

The Nominating Committee consisted of Gerrie Lee, Chairman, Jakie Harbin and Dr. Bob Clardy. The Committee nominated the following individuals for the following positions:

Board of Directors:

Dr. Peter Kingsford - Director- 3 year Term: Dr. Kingsford retired from Mobile County Public School System after 26 years with the last 16 years as principal at Augusta Evans School. He also completed a 19 year career at the University of Mobile, serving as Dean of the School of Education during the final 10 years. He is a Veteran of the United States Coast Guard.

Carlos Montgomery - Director - 3 year Term: Mr. Montgomery has served on MECU's Board of Directors since 2010 and on the Supervisory Committee in the past. He retired as Supervisor of Textbooks from the Mobile County Public School System after 36 $^{1\!/_2}$ years of service.

Christine Nassar - Director- 1 year Term: Mrs. Nassar retired from Mobile County Public School System in 2014 after 34 years with the system. During that time, she served as a classroom teacher, a chemistry specialist with Science in Motion and as a Secondary Science Supervisor.

Supervisory Committee:

Sue Smith - 3 year Term: Mrs. Smith has served on the Supervisory Committee since 2010. She retired from the Mobile Public School System as the Business Office Education Coordinator at Davidson High School after 35 years of service.

Barbara Scarbrough -1 year Term: Mrs. Scarbrough retired in 2001 from Mobile County Public School System after 25 years of service. Most of her employment was in the Adult Education Program.
