2022 NOMINATING COMMITTEE REPORT

The Nominating Committee consisted of Dr. Bob Clardy, Chairman, Isum Richardson, and Jakie Harbin. The Committee nominated the following individuals for the following positions:

Board of Directors:

Lloyd Scott -Director- 3 year Term: Mr. Scott has served on MECU's Board of Directors for over 7 years. He served the Mobile County Public School System for over 37 years and retired as Director - Environmental Studies Center.

Kathryn Smith -Director- 3 year Term: Mrs. Smith is a graduate of Alabama State University with a degree in History. She received her Master's degree in School Library Science from Atlanta University in Atlanta, GA. Kathryn is a native of Mobile, Alabama and has worked in the Mobile County Public School System as a Media Specialist for over 35 years.

G. Milton Williams - Director- 3 year Term: Mr. Williams has served the Mobile Educators Credit Union for many years on the Board of Directors and Supervisory Committee. He retired as Supervisor of Local School Accounting from the Mobile County Public Schools after 39 years of service.

Supervisory Committee:

Marilyn Howell- 3 year Term: Ms. Howell has served on the Supervisory Committee since 2016. Ms. Howell retired from the Mobile County Public School system as the Elementary Curriculum Supervisory after 42 years of service.
